Child Death Overview Panel - Ingestion of Button Disc Batteries

A recommendation from the review of a case was made to raise awareness of the danger posed from ingestion of button disc batteries, which are found in everyday objects, including toys and musical greeting cards. If ingested there is a risk it will not pass through the digestive tract in a timely manner. The impulses emitted from the battery can cause erosion of the gastrointestinal tract and lead to internal bleeding. If ingestion is known or suspected, medical assistance should be sought promptly. Anti-Social Behaviour, Crime and Policing Act 2014

The Anti-Social Behaviour, Crime and Policing Act 2014 was introduced in March 2014. The new Sexual Harm Prevention Orders and Sexual Risk Orders aims to disrupt sexual exploitation earlier, and will apply to under 18 as well as adults. The Home Office will be developing the new guidance on the implementation of the new orders.

Women and girls at risk

The Barrow Cadbury Trust, the Lankelly Chase Foundation and the Pilgrim Trust have published a review of the risk factors associated with negative outcomes (offending, homelessness, prostitution and exploitation) for girls and women.

Child Sexual Exploitation

A study funded by the Nuffield Foundation and carried out by Barnardo's, NatCen and UCL, has analysed the records of 9,042 children affected by **child sexual exploitation** and supported by Barnardo's since 2008. It reveals 1 in 3 (2,986) were boys, a much higher figure than was previously thought.

A report published of an independent inquiry into **child sexual exploitation in Rotherham**, estimates that approximately 1400 children were sexually exploited between 1997 and 2013. In over a third of cases, children were already known to children's services due to child protection and neglect concerns.
