Birmingham City Council CSE

A report by Birmingham City Council has revealed that 132 children and young people are experiencing or at risk of child sexual exploitation. Of those children, 44 are in care and 56 are under the age of 16.

Improving Futures success

An analysis of a National Lottery funded parenting support programme, Improving Futures, has shown that amongst participants there was a 49% reduction in children with persistent behavioural problems; and a 35% fall in levels of parental anxiety and frustration. **Source:** Children & Young People Now 08 December 2014

Young Carers

A Carer's Trust survey of 295 young carers aged between 14 and 25 has found that only 22% received a formal needs assessment from their local authority. Nearly 45% of young carers responding to the survey reported suffering from a mental health problem. **Source:** Community Care 10 December 2014

The BBC reports a huge increase in the number of children being admitted to hospital for self-harm. Between 2009-2014, admissions of girls aged 10-14 rose by 93% from 3090 to 5953. Admissions for boys rose from 454 to 659, a rise of 45%. **Source:** <u>BBC Online</u> 12 December 2014
