Issues include: not recognising the father's predatory, controlling and abusive behaviour as sexual exploitation and domestic abuse.

Oxfordshire Safeguarding Children Board (OSCB) has published a serious case review into the sexual exploitation of children in Oxfordshire. Issues include: professionals' lack of understanding of government guidance on the exploitation of children; insufficient investigation into what was happening and a tendency to see the victims as 'difficult girls making bad choices'.

New Measures to Tackle CSE

The Prime Minister has announced new measures to tackle child sexual exploitation. Proposals include: to introduce criminal sanctions for professionals who fail to protect children from sexual exploitation; a new helpline for whistleblowers in the public sector to report bad practice; and prioritising child sexual abuse as a 'national threat' which places a duty on police forces to collaborate across force boundaries to safeguard children.
