#### Child K Serious Case Review

**Southampton Safeguarding Children Board** has published a serious case review (SCR) into the death of a seven-year-old boy as a result of a serious head injury. The overview report noted that this child had suffered severe neglect and had been subject to physical, emotional and sexual abuse over a significant period of time.

The review noted serious systemic failures in child protection arrangements at a time of significant change in the design and delivery of children's services which led to a fluctuating workforce, poor leadership and a lack of response to issues raised.

#### Key findings include:

- *Failure to hear the voice of the child* – child not seen often enough by professionals involved and was not asked their views and feeling. Child K rarely seen alone by a social worker
  - On at least 3 occasions when Child K spoke of being physically harmed by stepfather but no action was taken:
  - In April 2010 Child K was seen to have bruising to his head in school and told teachers that his step-father had done this by banging his head on a bed and bicycle.
  - In October 2010 Child K hit another child in the face, saying that is what "daddy" did to him.
  - In June 2011 Child K spoke at school about "getting bruises off my dad".
- *Agencies did not listen to adults who tried to raise concerns* – child K's MGM repeatedly tried to raise concerns, as did workmen who an injured neglected four years old.
- *Practitioners focused too much on the needs of the parents* - domestic abuse of Ms L became the focus of agencies attention, to the detriment of Child K, and to a lesser extent, his siblings.
- *Agencies did not interpret their findings well enough to protect the child* – they did not identify the likelihood of physical abuse and were led by false confidence, for example terminating the child protection plan at the earliest opportunity and without and firm evidence of improvement in the situation.
- *Parents and carers prevented professionals from seeing and listening to the child* - may not apply in this case. Mother spoke about child's injuries, giving at times improbable explanations.
- *Working with hostile and avoidant families* - professionals may have been intimidated by step-father who was a violent man. He bluntly refused to engage with professionals even when the children were subject to a child

protection plan. Mother of Child K conspired with her partner to conceal the abuse of her son, perhaps some extent in fear for her own safety, or simply to prevent detection. She herself was seen to have directly mistreated Child K, in an incident in a supermarket and when he was in hospital.

**Lessons learnt include:** being alert to the possibility that a parent who is a victim of domestic abuse can also be abusive toward their children; professionals remembering that if they feel intimidated themselves by a parent or carer it is very likely a child would feel similarly threatened.

### **Button Batteries**

Button batteries are the very small disc shaped batteries found in many everyday gadgets and toys. If a button battery is swallowed it could get stuck causing the child to choke and/or cause the battery to produce sodium hydroxide (caustic soda). This is highly dangerous and can cause internal bleeding and/or burn a hole inside the body. They can also cause damage if placed in ears or noses. ### **Serious Crime Act 2015**

The [Serious Crime Act 2015](#) received Royal Assent on 3 March 2015 contains a number of wide-ranging provisions to pursue, disrupt and bring to justice, serious and organised criminals and gangs. Part 5 of the Act makes a number of distinct changes to the criminal law to enhance the protection of children from cruelty, protecting girls from female genital mutilation and strengthening the protection afforded to victims of domestic abuse:

- Updating and clarifying the offence of child cruelty to make it explicit that it covers psychological suffering or injury as well as physical harm. (Section 66)
- A new criminal offence of sexual communication with a child. (Section 67)
- Amends existing sexual offences legislation so as to recognise children as victims rather than consenting participants (Section 68)
- A new offence making it illegal to possess material that contains advice or guidance about abusing children sexually. (Section 69)
- Extends the extra-territorial reach of female genital mutilation offences and providing anonymity to victims. (Sections 70 and 71)
- A new offence of failing to protect a girl under 16 from the risk of female genital mutilation. (Section 72)
- Provision for female genital mutilation protection orders to protect victims and likely victims. (Section 73)
- A new duty on professionals to notify the police of acts of female genital mutilation. (Section 74)
- A new offence criminalising repeated or continuous coercive or controlling behaviour perpetrated against an intimate partner or family member which has a serious effect on the victim. (Sections 76 and 77)
