NSPCC

The NSPCC has published an evaluation report of **Assessing the risk: protecting the child**, an assessment service for men who pose a sexual risk to children and are not in the criminal justice system. Findings include: staff using the guide were positive about the holistic nature of the assessment process **Source:** NSPCC website 13 August 2015

Government

The Department for Education is consulting on proposals to close the annual data collection and publication of notifications of **private fostering arrangements**. Instead, they intend to gather information on private fostering through the existing annual children in need census. Consultation closes 15 September 2015.

New Publications

The Cabinet Office and the Department of Health have published a discussion paper which explores the



decrease in **'risky' behaviours in children and young people**, possible causes and what new risks could emerge. New, or previously unrecognised emerging behaviour includes a rise in self-harm and eating disorders, particularly amongst teenage girls.

Other Organisations

Community Care reports that Lancashire County Council has been sanctioned by the Local Government Ombudsman for **placing a homeless teenager in unsuitable accommodation** without assessing his needs as a looked after child.

The Guardian reports that up to 10,000 victims of **sexual abuse** are waiting more than a year for counselling, with many potentially never receiving treatment, due to a funding crisis facing specialist charities in the UK.

Community Care reports that Cafcass has received an all-time highest level of **care applications** for the second month in a row. In July 2015, it received 1,111 new care applications. This figures tops the 1,104 applications made in June.

NSPCC

The NSPCC is holding a series of consultations with **young people involved in sport**. The first one focused on worries young sports people have. Findings include: more than half of the 100 young people surveyed were most worried about injuries and tackles; one fifth had experienced verbal abuse; and 1 in 3 said that pressure to perform was a common problem.

Rethinking regulation

The Office for National Statistics has published data on **unexplained infant deaths in infancy in England**. 249 unexplained deaths occurred in 2013, a rate of 0.36 deaths per 1000 births. This is the first rise in unexplained infant deaths since 2008.

The Children's Society has published the results of an **international survey on children's wellbeing**. Findings include: children in England (aged 10 and 12) are unhappier with their school experience than in 11 other countries, ranking England 12th out of 15 countries surveyed. 38% of 10 and 12-year-olds in England have been physically bullied in the last month and half have felt excluded.

Ofsted has published **data on inspections of local authority children's services** published by June 2015. Key points include: almost a quarter (14) of local authorities were judged to be good for overall effectiveness; whereas just over one half (31) require improvement to be good.
