NSPCC

In an article on p.10 of Public Health Today, the NSPCC's Jon Brown outlines the collaborative actions across all levels of society needed to prevent **child sexual abuse**. The NSPCC's recently published report, **Preventing child sexual abuse: towards a national strategy for England**, presents knowledge about effective programmes and primary prevention interventions.

As part of the Impact and Evidence series, NSPCC has published an evaluation of the **Face to Face service** which supports children and young people aged between 5 and 18 who are in care or on the edge of care. Findings include: before receiving the Face to Face service 58% of children and young people had well being scores indicating clinical levels of distress, but by the end of their sessions this has reduced to only 15% of children.

Government

The BBC reports that the Work and Pensions Secretary has announced a new way of measuring child



poverty which will, in addition to income, consider other factors including educational achievement and living in workless households. The government will repeal the Child Poverty Act 2010 and has scrapped the definition of child poverty as living in a household with an income below 60% of the UK's average. The Department for Education has issued advice and social media guidance to schools and childcare providers to help them **keep children safe from the risk of radicalisation and extremism**.

Legal

In Scotland, Alison McInnes MSP has proposed an amendment to the Criminal Justice (Scotland) Bill to raise the age of criminal responsibility from eight to twelve.

The BBC reports that former MP Lord Janner will be prosecuted for allegations of **historical sex abuse** after an independent QC's review overturned the Crown Prosecution Service's decision not to prosecute him because he suffers from dementia.

New Articles

A BBC report investigates the struggle of some local authorities to cope with the large increase in the number of **children seeking asylum in the UK**.

An investigation by Community Care into **child sexual exploitation** has found that in the last two years social workers have received 11,276 referrals about children at risk of exploitation; and in 2013-14, referrals were up 31% on the previous year. Despite this rise in referrals the number of children going on to receive support dropped.

New Publications

As part of a review of progress made under the **Convention on the Rights of the Child**, the UK's 4 children's commissioners have submitted a report to the UN urging the government to reconsider its programme of deep welfare cuts and plans to repeal the Human Rights Act. The commissioners warn that the number of children living in poverty is set to rise to 4.7 million over the next five years. The report also voices 'serious concerns' about children being denied access to justice in the courts.

The Safeguarding Youth Sport (SYS) project has published a booklet which marks the end of the European SYS project. Its aim was to **safeguard elite young athletes** by improving training and competition conditions. The booklet gathers all information on the project and its results.

HMIC has published three reports related to **child protection**. The first is a summary of findings from 21 inspections of police responses to child protection; the second looks at findings of an inspection into how police deal with children being exploited online; and the third examines how successfully police share information in order to build a picture of criminality. Findings include: over half of police investigations into online child abuse are judged as inadequate or needing improvement.

The Care Quality Commission has published the results of a national survey representing the experiences of nearly 19,000 children and young people who received inpatient and day case care in 137 acute NHS trusts in 2014. Overall, children and parents or carers reported good experience of care. However, findings included: 35% of parents and carers said they were not definitely encouraged to be involved in decisions about their child's care and treatment.

The Children's Society has published a report analysing the **challenges facing vulnerable 16-17-year-olds as they transition to adulthood**. Findings include: 16-17-year-olds are more at risk of abuse and neglect at home, sexual exploitation and domestic violence than any other age group, yet there are gaps in legal protection for them and a lack of age appropriate support.

The Minister for Public Health has written to all NHS Trust chief executives, directors of public health and chairs of clinical commissioning groups across England highlighting the need for extra vigilance with respect to **female genital mutilation (FGM)** as we approach the school summer holidays. Justice Lovell Goddard has opened the **independent inquiry into historical child sexual abuse in England and Wales**. Due to last until 2020, it will investigate: whether institutions have failed to protect children from sexual abuse; whether they have since improved their child protection measures; and what else needs to be done to ensure children's safety. To support the inquiry, the NSPCC has launched a helpline run by trained counsellors for survivors of sexual abuse who wish to give evidence.

As part of the package of budget announcements, the Chancellor has pledged £30 million for local authorities to speed up the **adoption** process.

The Chancellor of the Exchequer has delivered the 2015 summer budget. He has outlined how he will cut £12bn from the welfare budget. Measures include: limiting support through child tax credit to two children from April 2017; reducing the benefit cap for families from £26,000 to £23,000 in London and £20,000 elsewhere in the UK. Charities are warning these measures will have a detrimental effect on **children** and young people in low income families.

Research

A study funded by the Medical Research Council has found that the **tools used to assess if asylum seekers are children** are wrong in more than a third of cases. Three of the methods used to identify markers of physical growth and development, namely x-rays of the hand wrist, MRI scans of the wrist and x-rays of the third molars, are very inaccurate.

Sir Michael Wilshaw, Her Majesty's Chief Inspector, has written a letter updating the Secretary of State for Education on the progress of the Birmingham and Tower Hamlets schools subject to targeted inspection in 2014. The letter expresses concern that the **failure to track pupils taken out of school** means an opportunity is being missed to identify children at risk of female genital mutilation, forced marriage, child sexual exploitation and radicalisation.

Deloitte have published a **stocktake of youth offending teams (YOTs)** in England and Wales, commissioned by the Ministry of Justice (MoJ). Findings include: The YOT system enables holistic interagency work which takes account of young people's wider needs, however the MoJ only measures outcomes around offending behaviour. Recommendations include: create new performance measures to capture broader desired outcomes and consider introducing a national Youth Justice worker accreditation scheme.

Goes through how to Explain the situation, discuss why the pupil is Acting this way, move on to talking about Repercussions of the bullying behaviour and finally look for Solutions together. The truth about neglect.

Summary:

Reports on a session on child neglect in a recent Optimus Education Protecting Children Update conference. The author points out that parental mental health issues, domestic abuse, and some environmental factors may increase the likelihood of neglect. Also points out that children with disabilities may be more prone to being neglected. Concludes with the suggestion to use a child-focused framework to assess neglect as recommended by Action on Neglect. Urges schools to consider their child protection plans so that they can accurately identify and act on all forms of child abuse.

Summary: Looks at examples of innovative practice in foster care in England. Briefly discusses key statistics and issues such as the difficulties in recruiting foster carers. Highlights practice inspired by overseas models including the NSPCC's New Orleans programme and the Fostering Network's use of social pedagogy. Provides more detail about a pilot scheme to establish "hub homes" of specially trained and recruited foster carers and BAAF's intensive fostering scheme which is used as an alternative to custody.

Reducing risk: families in wraparound intervention.

Summary: Outlines a case study of 308 children focusing on an intervention that uses a wraparound approach early during family stress or crisis to prevent a child's entry in to the child care system. Looks at the extent to which children with family members on the intervention can experience a reduction of the risk of child maltreatment recidivism six months after receiving the intervention. Finds that children whose caregivers completed the intervention experienced less maltreatment than those in a comparison group of similarly situated children.

Provides an overview of crisis intervention, the need for short-term effective treatments and highlights the clinical symptoms often encountered. Discusses child sexual abuse looking at its impact, recognition and reporting. Features a guide to practice offering suggestions on how to help a child and their family following disclosure. Includes chapters covering domestic violence, families in crisis, anger and aggression in children and adolescents as well as looking at the legal and ethical issues in



crisis intervention.

Summary: Study aid for students preparing for postgraduate, masters and higher exams in public health, and a definitive guide for the Part A examination for Membership of the Faculty of Public Health (MFPH). Summary: Looks at how literature can be used to help young asylum seekers and refugees who have been victims of violence overcome their experiences. Explores how the process of reading, discussing and rewriting selected texts can have a therapeutic impact. Looks at the use of images, symbols and metaphors to access trauma and the therapeutic use of dreams, fairy tales and myths. Considers the approaches and processes involved in implementing biblio/narrative therapy. Discusses the importance of ethics and good practice, cultural sensitivity and the role of the facilitator.

Books

How safe are our children?: the most comprehensive overview of child protection in the UK.

Summary: Compiles child protection data from government statistics and research findings to measure the extent of abuse and neglect in all four nations of the UK. Sets out 20 indicators covering: child deaths; recorded abuse offences; self-reported abuse; child protection actions; contacts with ChildLine and the NSPCC helpline; and public attitudes. Prominent trends show: an increase in recorded sexual offences against children and an increase in contacts to the NSPCC about sexual abuse in 2014-15; neglect remained the most common form of maltreatment; and the number of children dying as a result of homicide or assault remained in long term decline. Concludes that more support is needed for victims; tackling neglect should remain a priority; and early intervention is key to preventing abuse and neglect.

This studied the mothers' abilities to learn and practice new parenting skills while they were in the shelter. Finds that a combination of individual and group sessions was a successful method to improve the way mothers communicated with their children.

Summary: Examines the intergenerational continuity of potentially injurious physical discipline of children in a community sample in Japan. Uses data from the World Mental Health Japan Survey which found that the experience of physical discipline as children was associated with the use of physical discipline as parents. This association was independent of other childhood adversities, mental disorders and household income. Reports that the findings are consistent with similar studies on the intergenerational transmission of child physical abuse in other countries.

Summary: Considers factors that support desistance from sexual offending in those who have previously offended. Reviews the literature on protective factors supporting desistance and discusses the value of incorporating protective factors into the risk assessment process. Proposes eight potential protective domains: healthy sexual interests; a capacity for emotional intimacy; constructive social networks; goal directed living; good problem solving; employment; sobriety; and an optimistic attitude to desistance.

Protective strengths, risk and recidivism in a sample of known sexual offenders.

Finds that approximately 40 per cent of the sample re-offended in some way within the following 6-years. Reports that self-perceived ability to make better decisions, control temper, take part in education and employment and presence of social support all served to reduce the likelihood of sexual recidivism.

Chapters cover: genital signs of sexual abuse in girls; genital bleeding in prepubertal girls; anal signs of CSA; genital signs of CSA in boys; anogenital signs of accidental injuries; and sexually transmitted infections. Parent and child agreement on experience of potential traumatic events.

Summary: Longitudinal Swedish study exploring parent and child reports of trauma. Reports on responses to the Life Incidence of Traumatic Events (LITE) questionnaire from 1174 children, 875 mothers and 601 fathers, completed when the children were 12-years-old. Finds that agreement was low across most types of trauma reported and agreement was lower when the trauma was interpersonal. Highlights how a lack of parental recognition of trauma is likely to result in a failure to seek intervention and consequently poorer outcomes for the child. Emphasises the importance of seeking information directly from children.

Summary: Investigates risk and protective factors for severe physical and emotional abuse amongst a cross-sectional community sample of 603 South African 13-19-year-olds. Factors associated with severe physical and emotional abuse included: poverty, AIDS-related stigma, bullying, school non-attendance, family conflict, sexual abuse and living with a step-parent. Highlights the lack of research into risk and protective factors for physical and emotional child abuse in South Africa and a need for further research on the relationship between child abuse and caregivers with AIDS sickness.

Children looked after placements by English local authorities.

Summary: Presents information about the age, gender and ethnicity, of all children looked after on 31 March 2014. Finds that 68,554 children and young people were looked after by 151 English local authorities, an increase of 668 children on the previous year. Includes data about where all children looked after were living on 31 March 2014, including how far from their placing local authority they were living, the type of placement and how long they had been there. Finds that 51,301 of children were fostered, 6,093 were in children's homes and 3,561were placed for adoption

<u>Placement disruption: a review of cases of children in care in England and Wales where stable placements are threatened for financial reasons.</u>

Summary: Findings from a survey examining whether stable foster placements for children have been disrupted to cut costs. Of 19 responses by foster carers, nine said decisions had been made or plans changed for financially driven reasons. Looks at the statutory responsibilities of local authorities, Independent Reviewing Officers (IROs) and foster services in care planning. Sets out actions that can be taken by a social worker, carer or child to protect the interests of children when changes to care are proposed.

Reports on results from an initial evaluation, including: 99 per cent of parents who took part in the programme remembered watching the film; and 82 per cent of parents reported having used at least one of the tips suggested by the film. Discusses future plans for the programme.

Antenatal young parents: introducing a pathway to enhance health visiting practice.

Summary: Outlines the development of a health visiting practice pathway for young parents in the Humber Foundation NHS Trust area. Highlights research amongst this disadvantaged group around prevalence of domestic violence, infant mortality, poverty and child maltreatment. Potential challenges identified in delivering the pathway include issues engaging with fathers and partners. Argues that health visitors should use their skills of early intervention and partnership working to improve the health and wellbeing of young parents and their children.

Finds that social services were more likely to becomes involved in families with: maternal social and mental conditions; more than one child; and persistent SA dependency.

Reducing infant mortality in London: an evidence-based resource.

Summary: Describes what research tells us about the risk factors for infant mortality and what prevention strategies work. Analyses data on the rates and economic impact of infant mortality for London. Looks in detail at risk factors covering: child poverty; teenage pregnancy; access to antenatal care; smoking in pregnancy; maternal and infant nutrition; sudden unexpected deaths in infancy (SUDI); and vaccinations.

Summary: Explores the challenges facing 16-17-year-olds and what makes them particularly vulnerable. Finds: 16-17-year-olds are more at risk of abuse and neglect at home, sexual exploitation and abuse from their partners than any other age group; and that gaps and inconsistencies in UK law leave 16-17-year-olds unprotected. Recommendations include: increased and more flexible services; and greater participation of young people.

Building the picture: an inspection of police information management.

Summary: Inspection into how police forces in England and Wales collect, record, process, evaluate, share and dispose of information. Conducted as a result of findings in 'Mistakes were made', that reviewed police failings in sharing and recording allegations related to Jimmy Savile (HMIC, 2013). Analyses findings from a self-assessment survey completed by all 43 forces and three days of fieldwork in 13 forces. Identifies local variations in practice leading to a risk of failings in information sharing. Recommendations include all forces to review their policies and practice to ensure they comply with the Authorised Professional Practice on information management.

Review of the BBC whistleblowing and child protection policies and processes.

Summary: Conclusions from a review of the BBC's child protection and whistleblowing policies. Tests and examines the BBC's child protection policies against 49 criteria and its whistleblowing policies against 25 criteria. Finds that the BBC's whistleblowing policy was ranked at number 12 in a list of 40 organisations. Includes recommendations to help strengthen child protection and safeguarding policy and systems.

Councils struggle to meet rise in demand for child protection.

Summary: Investigates the rise in numbers of children in care and on child protection plans between March 2014 and March 2015. Freedom of Information requests to local authorities show that in those that responded, children in care have increased 1.26 per cent, children on protection plans increased by 7.36 and section 47 enquiries increased by 11.78 per cent. Describes which local authorities showed the largest increases. Concludes with a concern for adolescents who may not be receiving the same level of intervention as younger children.

<u>Domestic violence and voluntary perpetrator programmes: engaging men in the precommencement phase.</u>

Summary: Looks at why interventions aimed at male perpetrators of domestic abuse suffer from low levels of referrals/self-referral and high drop-out rates. Examines trends from two multi-agency interventions to identify key reasons for lack of male engagement, including: work with perpetrators was not within the remit of partner agencies; work with perpetrators was from a criminal justice perspective; agencies working with families focused on mothers and children; and female practitioners felt unsafe engaging with perpetrators. Concludes that programmes should engage with perpetrators earlier in the intervention and that social workers need more training in working with perpetrators.

Community reactions to young people who have sexually abused and their families: a shotgun blast, not a rifle shot.

Summary: Examines data on 117 young people with sexually harmful behaviour, to investigate the nature of community responses to young people's abusive behaviour. Common community responses included stigmatisation and social isolation. Reports that some young offenders and their families were attacked and forced out of their homes. Community responses sometimes heightened risk factors. Discusses policy and practice implications, including the need for caution about the inclusion of children in policies on community notification of sex offenders.

Rights, responsibilities and pragmatic practice: family participation in case reviews.

Summary: Explores family participation in the case review process. Examines published policy guidance across the UK; professional attitudes and practice; and family experiences. Finds that family involvement is an expectation in all four UK nations but there is limited practice guidance. Suggests that while family perspectives add invaluable insight, dilemmas exist in involving perpetrators in the research and about the 'deserved' nature of participation. Argues that the variable picture of family involvement in the UK reflects uncertainty about the purpose, value and role of family participation.

Summary: Findings from a review of 124 cases and interviews with police officers and staff in England and Wales about sexual exploitation, facilitated and enabled by the internet. Highlights a gap between police force priorities and practice on the ground. Finds: missed opportunities to investigate risks to other victims beyond an initial case; and backlogs in forensic analysis of computers resulting in offenders being released on bail. Highlights examples of good practice including advice and guidance for parents and carers. Recommendations include: using websites and social media channels to talk directly to children.
