Chelsea's Choice

This is hard hitting production, which raises awareness of CSE, what makes a healthy relationship and how to stay safe on the internet, and written for young people aged 12-14 (also suitable for older audiences) toured Leicester, Leicestershire and Rutland during autumn 16. The play lasted for approx. 35 minutes, with a 25 minute q&a session between the actors and students.

How schools can help

Schools should promote healthy relationships through their whole school approach, child protection policy, PSHE & SRE policies, behaviour policy, and anti-bullying work.

Senior management and governor commitment to deal with the issue of CSE is needed to ensure it is done in an appropriate and supportive way.

Designated Safeguarding Lead could organise sessions

for all staff to raise awareness of the risk factors, signs and indicators, useful resources and details of local services

for parents, perhaps in conjunction with specialist services.

Display posters and distribute leaflets to advertise services that children can use to get information and advice about CSE.

Link teaching with relevant school policies, including those on PSHE, SRE, e-safety, anti-bullying and child protection will help to ensure clear links with the whole school approach.
